## OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION DECEMBER 6, 1961

The regular monthly meeting of the Greater Lafourche Port Commission, which was postponed from December 4 to December 6, 1961, was held that date at the domicile of the Commission at 2:00 o'clock P. M. The meeting was called to order by the President. The roll was called.

The minutes of the November 16, 1961 meeting were read by the Recording Secretary. On motion of Neb Chauest, seconded by Daize Cheramie and unanimously carried, it was moved that the minutes be approved as read.

The President appointed a Finance Committee. Members are:

Board Member Egle' then inquired as to what progress had been made toward removing the rocks from the channel in Belle Pass. President Rappelet advised that he had been in contact with the Louisiana Dept. of Public Works to secure the services of an engineering aide, but was informed by the Department that no engineer could be made available for at least thirty to forty-five days. President Rappelet then stated that he would contact the Lafourche Parish Levee Board and attempt to borrow an inspector from it. Board Member Chouest then stated that due to the fact that the project was of an emergency nature the board proceed toward removing the rocks from the channel

without engineering advice, but appoint someone to inspect the job. The Board recommended that the contractor be requested to proceed at the earliest possible date.

Two Representatives of the California Company arrived and discussed their application for a permit in Round Lake. The Board took the application under advisement.

President Rappelet then advised that Mr. Morgan of the Department of Public Works would complete his survey of the Havoline Canal, Evans Canal and Fourthon Pass within next week of so.

The Board entered into a **discu**ssion into the possibility of securing a light for Belle Pass and indicated that it would investigate the feasibility of such a light.

President Rappelet then reported to the Board that the services of an Accountant were needed by the Port Commission. Board Member Gremillion stated that Mr. Graham Reeves was a competent accountant and that perhaps he would be available for the Board. President Rappelet then requested that Board Member Gremillion contact Mr. Reeves and arrange a meeting concerning his availability as the Commission Accountant.

The Recording Secretary was requested to consult with the attorney for the Board and write letters to Texas Company and Keystone, relative to their operation in the tenth ward of the Parish.

It was moved by Euzebe Chouest, seconded by Harrison Cheramie, and unanimously carried, that each piece of equipment purchased by the Port Commission be appropriately stencilled denoting that it is the property of the Commission. Mr. Gremillion was to contact necessary Company to get proper equipment for same.

On motion of Dudley Bernard, seconded by Luke Charpentier, and unanimously carried, the meeting was adjourned.
