

OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

AUGUST 13, 1973

The Greater Lafourche Port Commission of the State of Louisiana met in regular session at the Tenth Ward Annex Building in Galliano, Louisiana on Monday August 13, 1973, at 4:00 P.M., pursuant to the provisions of due notice given in writing to each and every member thereof and duly posted in the manner provided by law.

There were present: Andrew Martin, Irvin Melancon, Jr., Harrison Cheramie, Jr., Adam Gisclair, Jr., Loyman Terrebonne and Anson Toups.

There were absent: Nolty Theriot, Antoine Estay and Tomey Doucet.

In the absence of Nolty THERiot, President, the meeting was duly convened by Andrew Martin, who ;announced the purpose of the meeting in accordance with the aforesaid written notice and then stated that the commission was ready for the transaction of business.

Andrew Martin also read the minutes of the last meeting held on June 11, 1973, It was moved by Anson Toups, seconded by Loyman Terrebonne and duly passed that the minutes be accepted as read.

General Manager, Irvin Melancon, Jr., gave a report on the Board Members trip to Washington D.C. where the Greater Lafourche Port Commission made a presentation before the Senate Committee on Interstate and Foreign Commerce on behalf of the proposed Superport.

## ADVERTISEMENT FOR BIDS

Sealed proposals for construction of a Distribution System Extensions will be received by the Board of Commissioners, Greater Lafourche Port Commission, at the Lafourche Parish 10th Ward Annex Building, Galliano, Louisiana, until four-fifteen (4:15) P.M., Central Standard Time, September 10, 1973, and immediately thereafter publicly opened and read.

Plans, Specifications and Proposal Forms may be obtained at the office of Picciola & Associates, Inc., 4514 Louisiana Highway No. 1, P. O. Box 758, Galliano, Louisiana 70354, up to within twenty-four (24) hours prior to the time for receiving proposals, for \$30.00 per set with no refund.

Each bid must be accompanied by a satisfactory bid bond in the amount equal to five percent (5%) of the amount of the proposal.

No proposal will be considered unless it is accompanied by satisfactory evidence that the bidder holds Louisiana State Contractor's license of proper classification and in full force and effect, in compliance with Act. Louisiana R.S. 37:2151-63.


The successful bidder will be required to execute a performance and payment bond covering all labor and materials in the amount equal to one hundred percent (100%) of the contract amount.

No bid may be withdrawn for a period of thirty (30) days after the time for receiving bids.

The Owner reserves the right to reject any or all proposals and to waive informalities.

There was a question and answer period in which the audience inquired about various phases of port operations.
