

OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

SEPTEMBER 10, 1973

The Greater Lafourche Port Commission of the State of Louisiana met in regular session at the Tenth Ward Annex Building in Galliano, Louisiana on Monday September 10, 1973, at 4:00 P.M., pursuant to the provisions of due notice given in writing to each and every member thereof and duly posted in the manner provided by law.

There were present: Antoine Estay, Tomey Doucet, Harrison Cheramie, Jr., Adam Gisclair, Loyman Terrebonne and Anson Toups.

There were absent: Nolty Theriot, Andrew Martin and Irvin Melancon, Jr.

In the absence of the President, Nolty Theriot, the meeting was duly convened by Antoine Estay, who announced the purpose of the meeting in accordance with the aforesaid written notice and then stated that the Commission was ready for the transaction of business.

In the absence of the Secretary, Andrew Martin, Anson Toups read the minutes of the last meeting held on August 13, 1973. It was moved by Anson Toups, seconded by Adam Gisclair, Jr., and duly passed that the minutes be adopted as read.

Port Engineer, Marco Picciola announced that it was time to open the bids for the construction of a Potable Water Line at Port Fourchon. He asked if anyone in the audience had not yet turned in their bid to please do so. All bids were then opened and read aloud as follows:

Marco Picciola announced that all bids would be reviewed by both the Port Commission board and the Water District board as well as each board's engineers. The successful bidder would then be notified of the boards decision.


There was a question and answer period in which the audience was given the opportunity to make inquiries concerning Port activities.
