

OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

OCTOBER 8, 1973

The Greater Lafourche Port Commission of the State of Louisiana met in regular session at the Tenth Ward Annex Building in Galliano, Louisiana on Monday October 8, 1973, at 4:00 P.M., pursuant to the provisions of due notice given in writing to each and every member thereof and duly posted in the manner provided by law.

There were present: Nolty Theriot, Antoine Estay, Andrew Martin, Tomey Doucet, Irvin Melancon, Jr., Harrison Cheramie, Jr., Adam Gisclair, Jr., Loyman Terrebonne and Anson Toups.

The meeting was duly convened by the President, Nolty Theriot, who announced the purpose of the meeting in accordance with the aforesaid written notice and then stated that the Commission was ready for the transaction of business.

RESOLUTION

BE IT RESOLVED: That the Greater Lafourche Port Commission does hereby authorize the Commission engineer, Picciola & Associates, to make the proper application for a permit to the U. S. Army Corps of Engineers, along with all applications necessary for "Letters of No Objection" from whatever other agencies having jurisdiction in the Port Fourchon area. These applications being for the extension of the east stone jetties and construction of new west stone jetties at the mouth of Belle Pass, along with dredging operations necessary to maintain the channel demensions at 20'x300'.

WHEREAS, the Greater Lafourche Port Commission has assumed the responsibility of acquiring all necessary property or rights-of-way to effectuate such construction, and

WHEREAS, the Greater Lafourche Port Commission has not yet completed negotiations for the acquisition of all the property or rights-of-way necessary for these waterworks facilities;

NOW, THEREFORE, BE IT RESOLVED: That the Greater Lafourche Port Commission does hereby assume the responsibility for any financial and legal liability which may arise out of the untimely acquisition of sites for the proposed Booster Station and Elevated Storage Tank in connection with the water main extension program to the Por Facilities.

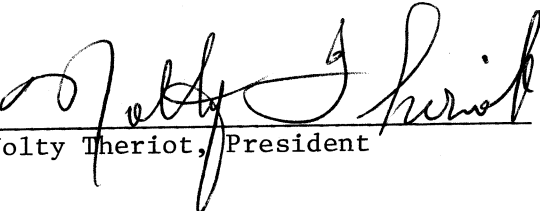
## RESOLUTION

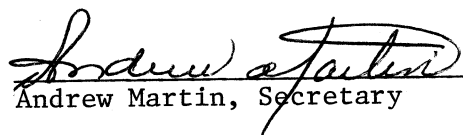
RESOLVED: That the Greater Lafourche Port Commission does hereby accept the bid of Larry Doiron, Inc. in the amount of \$504,886.51, with project completion in 180 working days. This bid being the lowest bid submitted for both the construction cost and time element involved for a water disribution system to the Port Fourchon facilities.

BE IT FURTHER RESOLVED: That the President, Nolty Theriot, or the Vice-President, Antoine Estay, are hereby authorized by and on behalf of the Greater Lafourche Port Commission to sign any and all documents necessary for the construction of this water distribution system.
