

OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

SEPTEMBER 15, 1982

The Greater Lafourche Port Commission of the State of Louisiana met in special session in the Conference Room of the Commission Administration Building in Galliano, Louisiana, on Wednesday, September 15, 1982, at 10:00 A. M. pursuant to the provision of due notice given in writing to each and every member thereof and duly posted in the manner provided by law, the purpose thereof being to accept bids.

There were present: Roland J. Guidry, Louis Chabert, Tomey J. Doucet, Harrison Cheramie, Jr. and Vhores Trosclair, Jr.

There were absent: Reed Danos, Andrew Martin, Paris "Pye" Theriot and Dudley Bernard

In the absence of the President, Vice President Roland Guidry convened the meeting and announced the purpose thereof in accordance with the aforesaid written notice.

After checking the bids in connection with the Harbor Police vehicles, and since all specifications were met, the Board agreed to accept the bid of Cliff Motors Co.

Upon motion by Harrison Cheramie, Jr., seconded by Vhores Trosclair, Jr. and unanimously passed, the Board agreed to accept the low bid of Cliff Motors Co. of \$10,460.00 per vehicle (including tax & title).

After checking the bids in connection with the furnishing of clamshells and since all the requirements were met, the Board agreed to accept the bid of Lafourche Materials Co.

Upon motion by Tomey Doucet, seconded by Louis Chabert, the following resolution was adopted by the following vote:

RESOLVED, that the Board of Commissioners of the Greater Lafourche Port Commission accept the bid of Lafourche Materials Co. at \$13.15 per yard in connection with the furnishing of clamshells, tailgate spread, under a one year contract.

After checking the bids in connection with the 40' x 80' building, and since all the requirements were met, the Board agreed to accept the bid of Javy J. Pertuit Contractors.


Upon motion by Tomey Doucet, seconded by Vhores Trosclair, Jr., the following resolution was adopted by the following vote:


