OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION July 26, 2006

The Board of Commissioners of the Greater Lafourche Port Commission met in special session on Wednesday, July 26, 2006 at 11:45 AM.

Vice President Lafont called the meeting to order, and Commissioner Melancon called the roll.

PRESENT: Chuckie Cheramie, Jimmy Lafont, Larry Griffin, John Melancon, and Ervin Bruce

Upon motion by John Melancon and second by Chuckie Cheramie, the board unanimously approved the request by Mayeux's Flying Service, Inc. to assign their lease along 16th Street (Site 351) to C-Port, LLC. President Vizier is authorized to execute said assignment.

Upon motion by Chuckie Cheramie and second by Larry Griffin, the board unanimously approved the request by Boudreaux Contractors to sublease 49% of their lease to Smith Services for storage of drill pipe and other equipment.

Upon motion by Ervin Bruce and second by John Melancon, the board unanimously approved the request from Bollinger Fourchon, LLC to sublease to Martin Chemist of Louisiana for the location of an on-site trailer.

Upon motion by John Melancon and second by Larry Griffin, the board unanimously awarded the low bid by Mike Hooks, Inc. in the amount of \$4,598,569.14 for the Northern Expansion Dredging project and authorized Director Falgout to execute contract documents.

Upon motion by Ervin Bruce and second by John Melancon, the board unanimously approved the Substantial Completion Certificate by United Dredging for Bucket Dredge Project #2 and authorized Director Falgout to execute certificate.

Upon motion by John Melancon and second by Larry Griffin, the board unanimously accepted Change Order No. 1 by United Dredging for Bucket Dredge Project #1 which increases the cost by \$17,622.20. Director Falgout was authorized to execute said change order.

Upon motion by Larry Griffin and second by Chuckie Cheramie, the board unanimously accepted Change Order No. 2 by United Dredging for Bucket Dredge Project #2 which increases the cost by \$22,297.84. Director Falgout was authorized to execute said change order.
