PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION OF THE STATE OF LOUISIANA, TAKEN AT A SPECIAL MEETING HELD ON SATURDAY, FEBRUARY 25, 1961.

The Greater Lafourche Port Commission of the State of Louisiana met in special session at its regular meeting place, the Office of the Greater Lafourche Port Commission, Galliano, Louisiana, on Saturday, February 25, 1961, at two (2:00) o'clock pomo, pursuant to proper notice duly given and posted as required by law.

There were present: Senator A. O. Rappelet, President, and Members Leo J. Theriot, Clerville Kief, Jack Egle and Dudley Bernard.

There was absent: Joe Defelice and Charles R. Ferris.

The Greater Lafourche Port Commission of the State of Louisiana was duly convened by Senator A. O. Rappelet, President, who announced the purposes of the meeting in accordance with the aforesaid notice thereof and then stated that the Commission was ready for the transaction of business.

In view of the absence of Mr. Joe Defelice, Secretary of said Commission, it was moved by Mr. Dudley Bernard, seconded by Mr. Leo J. Theriot and unanimously carried that Mr. Clerville Kief be and he is hereby appointed and designated as Acting Secretary of said Commission for the purposes of this meeting.

The following resolution was offered by Mr. Leo J. Theriot

and seconded by Mr. Dudley Bernard:

RESOLUTION

A resolution making application to the Board of Liquidation of the State Debt and to the State Bond and Tax Board for consent and authority to hold a special election in the port area of the Greater Lafourche Port Commission and, in the event said election carries, for further consent and authority to levy a tax in said port area and issue bonds of said Port Commission and provide for the payment thereof.

BE IT RESOLVED by the Greater Lafourche Port Commission of the State of Louisiana, acting as the governing authority of its Port Area:

SECTION 1. That application be and the same is hereby formally made to the Board of Liquidation of the State Debt, Baton Rouge, Louisiana, and to the State Bond and Tax Board, Baton Rouge, Louisiana, for consent and authority to hold a special election in the port area of the Greater Lafourche Port Commission of the State of Louisiana, said port area consisting of the entire tenth ward of the Parish of Lafourche, as the boundaries and limits of said ward existed on the date of the creation of said Commission, under the provisions of Chapter 13, Title 34 and Part II of Chapter 4, Title 39 of the Louisiana Revised Statutes of 1950, and other constitutional and statutory authority supplemental thereto, at which election there will be submitted to the resident property taxpayers of said port area qualified and entitled to vote at said election under the Constitution and Laws of this State, the following proposition, to-wit:

PROPOSITION

Shall the Greater Lafourche Port Commission levy within the port area (consisting of the entire tenth ward of the Parish of Lafourche, State of Louisiana, as the boundaries and limits of said ward existed on the date of the creation of said Commission), an ad valorem tax of five (5) mills on all the property subject to State taxation in said port area, beginning with the year 1961, for the needs and lawful purposes of said Commission, said tax to constitute revenue of the Commission which may be pledged to the payment of negotiable bonds or notes issued by the Greater Lafourche Port Commission in the manner provided by law?

SECTION 2. That application be and the same is hereby further made to said Board of Liquidation of the State Debt and said State Bond and Tax Board, in the event said proposition carries, for further consent and authority to levy the tax and provide for the collection thereof.

SECTION 3. That application be and the same is hereby further made to said Board of Liquidation of the State Debt and said State Bond and Tax Board, in the event said proposition carries, for further consent and authority for the Greater Lafourche Port Commission to incur debt and issue its bonds under the authority of Chapter 13, Title 34 of the Louisiana Revised Statutes of 1950, and other constitutional and statutory authority supplemental thereto, said bonds to be in the principal amount of not exceeding One Million Five Hundred

Thousand Dollars (\$ 1,500,000.00), to bear interest at a rate not exceeding five per centum (5%) per annum, to mature over a period not exceeding twenty-five (25) years and to be issued for the purposes set forth in the foregoing proposition.

SECTION 4. That certified copies of this resolution shall be forwarded to said Board of Liquidation of the State Debt and said State Bond and Tax Board by the Secretary of this Commission, together with letters requesting the prompt consideration and approval of the respective applications.

RESOLUTION

A resolution ordering and calling a special election to be held in the port area of the Greater Lafourche Port Commission of the State of Louisiana to authorize the levy of a tax in said port area for the needs and lawful purposes of said Commission.

BE IT RESOLVED by the Greater Lafourche Port Commission of the State of Louisiana, seting as the governing authority of its Port Area:

SECTION 1. That, subject to the approval of the Board of Liquidation of the State Debt and the State Bond and Tax Board, and under the authority conferred by Chapter 13, Title 34 and Fart II of Chapter 4, Title 39 of the Louisiana Revised Statutes of 1950, and other constitutional and statutory authority supplemental thereto, a special election be and the same is hereby called and ordered to be held in the port area of the Greater Lafourehe Port Commission of the State of Louisiana, said port area consisting of the entire tenth ward of the Parish of Lafourche, as the boundaries and limits of said ward existed on the date of the creation of said Commission, on Saturday April 8

1961, between the hours of six (6:00) o'clock a.m. and eight (8:00) o'clock p.m., in compliance with the provisions of Section 1181.1 of Title 18 of the Louisiana Revised Statutes of 1950 (R.S. 18:1181.1), and that at said election there shall be submitted to the resident property taxpayers of said port area, qualified and entitled to vote at said special election under the Constitution and Laws of this State, the following proposition, to-wit:

PROPOSITION

Shall the Greater Lafourche Port Commission levy within the port area (consisting of the entire tenth ward of

the Parish of Lafourche, State of Louisiana, as the boundaries and limits of said ward existed on the date of the creation of said Commission), an ad valorem tax of five (5) mills on all the property subject to State taxation in said port area, beginning with the year 1961, for the needs and lawful purposes of said Commission, said tax to constitute revenues of the Commission which may be pledged to the payment of negotiable bonds or notes issued by the Greater Lafourche Port Commission in the manner provided by law?

That there shall be published in "The Lafourche Comet", a semi-weekly newspaper, and "The Lafourche Parish Press", a weekly newspaper, both published in the City of Thibodaux, Parish of Lafourche, State of Louisiana (there being no newspaper published within said port area), for thirty (30) clear days in accordance with law, notice of said election, which notice shall embrace substantially all things set forth in this resolution and also notice that the Greater Lafourche Port Commission, the governing authority of said port area, will meet in special session at its regular meeting place, the Office of the Greater Lafourche Port Commission, Galliano, Louisiana, on Monday, April 10, 1961, at two (2:00) o'clock pom., and will then and there in open and public session proceed to open the ballot boxes used at the said election, examine and count the ballots in number and amount, examine and canvass the returns and declare the result of the said election.
