OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION AUGUST 14, 1961

A special meeting of the Greater Lafourche Port Commission was held, pursuant to written notice to all members, at the domicile of the Commission on August 14, 1961, at 2:20 P. M. The meeting was called by the President, A. O. Rappelet, who presided.

President Rappelet advised that Recording Secretary, Mrs. Mary Bernard was on vacation and J. A. Egle was asked to take minutes of the meeting.

President Rappelet read previously adopted resolution requesting permission for loan of \$25,000.00 and letter of approval by State Bank and Trust Co. Rappelet advised that the State Bond and Tax Board had verbally stated that loan was approved and that letter of authority would be mailed.

Mr. Rappelet then read letters of resignation of Clerville Kief and Legal Counsel, Mr. Edward Diaz. He also advised that letter of resignation was received by Governor Davis from Joseph Defelice.

Because the Port Commission did not have any funds at this time, consideration of bills payable by the Commission was postponed until the next regular meeting by motion duly made and seconded and voted on.

President Rappelet then called on Mr. Joe Horan for information concerning the new Area Redevelopment Act (87-27) and how our area might receive some assistance.

Mr. Horan then explained that he had checked before coming down and found that Lafourche Parish did not qualify as an under or unemployment

area, and that before any grant or loan could be considered that an area must be classified. In answer to the question, "Can an area be classified without including a full Parish?", Mr. Horan stated that the act was not explicit, but did not state that it was necessary. It was stated that Mr. William Batts of the U. S. Dept. of Commerce was area redevelopment administrator. Mr. Horan also stated that an area to receive assistance must first be classified as A (A-Statistics- Unemployment) or B (B- Low Income- Underemployment) distressed area and could be classified by Dept. of Unemployment Security, Department of Agriculture, or the Dept. of the Interior. The port area, because of its resources industry, could probably best be classified by the Dept. of Interior.

Mr. Horan further stated that, after being designated or classified, special project could be asked for. He suggested that a Development Committee be established to work on this.

In response to question of necessary support of request, Mr. Horan stated that any study, facts, or plan that is readied and given could assist greatly in speeding up and supporting request for assistance.

Commission was advised that Mr. S. J. Haycraft was the Louisiana representative of the U. S. Area Redevelopment Administration.

After discussion, a motion was duly made and seconded and voted by the members present, that application be made for Federal funds to aid in providing planning for the area and that special study needed for assistance in redevelopment projects be undertaken immediately by Carter, Horan & Chapin Planning Consultants.

There being no further business, the meeting was adjourned at 4:50 o'clock P. M.

Dear Senator Rappelet:

We are pleased to have been selected to work on an advanced planning grant with the Lower Lafourche Planning Commission. I am sending you a copy of the Resolution signed by Mr. Theriot, which states the Port Commission will supply the funds to obtain this grant, together with an outline of service. Filling out this application at this time prevents about six (6) months delay.

It is our understanding that an overall economic development plan is desired. Therefore, we are commencing drafts on the preliminary at once.

Declaration of Ward 10, Lafourche Parish, Louisiana, as a depressed area seems possible, due to the failing shrimp crop and its effect on the fishermen of the area. This would be handled by the Department of Interior, whom I understand are presently investigation the problem. The crop, I have been told, is 50% below normal, which is bound to put a strain on the people, their suppliers, and the lending agencies. An appeal to Washington on this critical matter might produce results. I believe Mr. Seaton Thompson was the Washington Representative who visited the area from the Department of Interior.

I do not think that the problem extends throughout the parish, but we will check other economic indicators.

RESOLUTION

WHEREAS, the Federal Housing Act of 1954 as amended, authorises grants of federal funds to official state planning agencies to aid them in providing, planning assistance to areas with populations of less than 50, 000;

WHEREAS, the Planning Division of the Department of Public Works, State of Louisiana, is the official planning agency for the State of Louisiana, and, as such, is qualified to receive grants of federal funds under the provisions of said act;

WHEREAS, under the provisions of the said Federal Housing Act of 1954, the said Department of Public Works may apply to the federal government for 39% of the cost of each planning project and may require the area receiving planning assistance to contribute 25% of the said cost;

WHEREAS, in order to sectore the benefits of the said Federal Housing Act to as many qualified areas as possible, the said Department of Public Works has adopted the policy of requiring each area receiving assistance to contribute 25% of the cost of the project;

WHEREAS, the funds necessary to defray the expenses of the said planning project must be deposited with the said Department of Public Works and administered by it;

NOW, THEREFORE, BE IT RESOLVED by the Greater Lafourche Port Commission of the 19th Ward of Lafourche Parish in regular session convened that the Planning Division of the Department of Public Works, State of Louisiana, be and is requested to provide this area with planning assistance comprising such studies, surveys, technical services and other planning works as to the said Department will appear desirable under the existing circumstances.

BE IT FURTHER RESOLVED that the said Department of Public Works, State of Louisians, be and is assured that this Commission will bear (3/00°) of the total cost of furnishing said planning assistance, which money will be appropriated to that purpose and deposited with the said Department of Public Works upon approval of application by H. H. F. A., to be administered and disbursed by it.
