## OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

The regular monthly meeting of the Greater Lafourche Port Commission was held pursuant to written notice to all members at the domicile of the Commission on April 2, 1962 at 3:00 o'clock P. M. The meeting was called to order by the President and the roll was called.

On motion of Euzebe Chouest, seconded by Harrison Cheramie, the minutes of the February 12th meeting were approved as corrected.

The minutes of the meeting of March 6th were read by the Recording Secretary. On motion of Euzebe Chouest, seconded by Harrison Cheramie, and unanimously carried the minutes were approved as read.

Copies of the financial report prepared by the accountant were submitted to the members of the Commission.

On motion of John Egle', seconded by Euzebe Chouest and unanimously carried, it was moved that the Greater Lafourche Port Commission join the National Rivers and Harbors Congress at a membership fee of \$100.00 per year.

On motion of Euzebe Chouest, seconded by Luke Charpentier, and unanimously carried, it was

RESOLVED, that Ordinance No. 3 be adopted to read as follows:

## ORDINANCE NO. 3

An ordinance levying and imposing taxes on all the property subject to taxation in the port area of the Greater Lafourche Port Commission of the State of Louisiana for the year 1962.

BE IT ORDAINED by the Greater Lafourche Port Commission of the State of Louisiana, acting as the governing authority of its Port Area:

SECTION 1. That acting under the authority of a special election held in the port area of the Greater Lafourche Port Commission of the State of

Louisiana (consisting of the entire tenth ward of the Parish of Lafourche, State of Louisiana, as the boundaries and limits of said ward existed on the date of the creation of said Commission), on April 8, 1961, a special tax of five (5) mills on the dollar of the assessed valuation of all the taxable property in said port area be and the same is hereby levied, assessed and imposed on all of said property for the year 1962, for the needs and lawful purposes of said Commission.

SECTION 2. That the proper administrative officers of the Parish of Lafourche, Louisiana, be and they are hereby empowered, authorized and directed to spread said tax, as hereinabove set forth, upon the Assessment Roll of said Parish for the year 1962 and to make the collection of the tax imposed for and on behalf of said Commission according to law, and that the collection thereof shall be enforceable in the manner provided by law.

SECTION 3. That this Ordinance shall be published in "The Lafourche Comet, a newspaper published in the City of Thibodaux, Louisiana, in the manner provided by law.

This ordinance having been fully discussed and adopted by sections at a public meeting of said Commission received the following vote:
