The Vice-President, Paris Theriot, convened the meeting and announced the purpose of the meeting in accordance with the aforesaid written notice and then stated that the Commission was ready for the transaction of business.

Recording Secretary was further directed to re-invest Certificate of Deposit No. 1043 which matures July 17, 1978 with the financial institution quoting the best rate of interest and for the period most conducive to the Port's anticapated budget.

On motion by Harrison Cheramie, Jr., seconded by Norman Doucet, and duly passed that the Port Commission would purchase the Xerox Copier, that until now has been leased.

It was moved by Reed Danos, seconded by Tomey Doucet, and duly passed that the new rate schedule submitted by Picciola & Associates be accepted.

Upon advisement by Picciola & Associates, the Vice-President instructed the recording secretary to draft a letter for signature to Boh Brothers Construction Co. informing them that time has elapsed on their contract with the Port Commission.

Norman Doucet reported the progress made with the Coast Guard for the return and placement of six buoys.

Reed Danos reported that Congressman Dave Treen could meet with the board Saturday, July 15, 1978 at 10:00 A.M. to discuss navigational problems in the port area.

Harbor Police Supt. Mack Picou informed the Board of the hiring of Simon Plaisance as a Police Officer; gave the H. P. report for the past month and reported on several problems in the port area.

The Board instructed Supt. Picou to purchase approximately 300 stakes for the Bayou Andrea area.
