On a motion by Norman Doucet, seconded by Nerby Collins, said motion being duly passed, the Harbor Police Expense Account Policy was approved as follows:

- I Lodging on approved trips.
- Meal allowance of \$2.50 per eight hour tour of duty with no receipt required.

  Meals for travel outside the Port area will be reimbursed in the amount of
  \$3.00 for breakfast, \$5.00 for lunch, and \$7.00 for dinner with no receipt required.

  If a special meal cost is encountered because of a meeting between two or more
  departments, receipts, names of guest, their affiliation, and reason for meeting must
  be attached to expense voucher. Tips are added to the receipt for special meals only.
- III A standard monthly allowance of \$30.70 will be paid to Harbor Police Officers for the purpose of laundry, gun use, ammunition (other than initial issue), batteries (other than initial issue), washing of vehicles, key duplications, and other expenses incurred by officers and not furnished by the Port.

The Greater Lafourche Port Commission makes the initial issuance of the following equipment to all newly appointed Harbor Police:

Police Officers will be furnished with a properly equipped vehicle during duty and a properly equipped boat (when needed).

Materials required for special assignment and for training or reference will be provided by the Port.

Upon a motion by Tomey Doucet, seconded by Pye Theriot, said motion being duly passed, that the Executive Director is authorized to contact the news media and have published that the Greater Lafourche Port Commission would proceed to enforce Ordinance No. 20 which deals with the throwing of trash and waste matter in the waters of the Greater Lafourche Port Commission District.

The Executive Director was further authorized to contact all organizations that would be interested in helping to "clean up our bayou".

Mr. Robert Bourg came before the board on behalf of himself and the Constantine family, to request the Port Commission's assistance in the disposal of two barges and cement slabs. Several of the board members agreed to meet with Mr. Bourg to look over the problem.

On motion by Tomey Doucet, seconded by Norman Doucet, and unanimously passed, the Executive Director was authorized to send a letter to Dowell requesting their use of local services, where available on a competitive basis.

A motion was made by Roland Guidry, seconded by Reed Danos, said motion being duly passed, that the meeting adjourn.
