## OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION

May 14, 1979

The Greater Lafourche Port Commission of the State of Louisiana met in regular session in the Conference Room of the Commission Administration Building in Galliano, Louisiana, on Monday, May 14, 1979 at 3:00 P.M. pursuant to the provision of due notice given in writing to each and every member thereof, and duly posted in the manner provided by law.

There were present: Paris "Pye" Theriot, II, Tomey Doucet, Harrison Cheramie, Jr., Reed Danos, Norman Doucet, Ted Martin and Roland Guidry.

Upon a motion by Harrison Cheramie, Jr., seconded by Tomey Doucet, said motion being duly passed, that the following resolution be adopted:

BE IT RESOLVED: That the Greater Lafourche Port Commission feels that it does not have the resources necessary to accept the responsibility of being the assuring agency for the Lafourche Jump Waterway Project.

Upon a motion by Tomey Doucet, seconded by Reed Danos, said motion being duly passed, that the following resolution be adopted:

BE IT RESOLVED: That the recording secretary is authorized to draft a check for the back payment of Joyce Anselmi's salary from June 1, 1978 thru June 26, 1978.

BE IT FURTHER RESOLVED: That the recording secretary is also authorized to pay Joyce Anselmi for her accumulated annual leave according to Civil Service Rule 11:10.

Upon a motion by Tomey Doucet, seconded by Roland Guidry, said motion being duly passed, that the following resolution be adopted:

BE IT RESOLVED: That the President or the Vice-President is hereby authorized to sign all documents necessary for the \$1.6 million grant from C.E.I.P.

Upon a motion by Ted Martin, seconded by Tomey Doucet, said motion being duly passed, that the following resolution be adopted:

BE IT RESOLVED: That the President or Vice-President are hereby authorized to sign a lease with NL Industries, Inc. for Petroleum Site No. 2 at Port Fourchon, at the rate of \$2.75 per front foot, with there being approximately 1250 feet of waterfront.

On a motion by Tomey Doucet, seconded by Norman Doucet, said motion being duly passed that the Executive Director is authorized to hire a garbage truck from Solid Waste Disposal, Inc. up to a maximum of four (4) days to clean the trash out of the bayou. The Executive Director was instructed to advertise the fact that the Port Commission would be cleaning up the bayou and thereafter violators would definitely be cited.

On a motion by Ted Martin, seconded by Roland Guidry, said motion being duly passed, that the Executive Director is hereby authorized to spend up to \$5,000.00 to have pilings driven into the areas in Port Fourchon where the road is about to erode.

A motion was made by Tomey Doucet, seconded by Reed Danos, said motion being duly passed, that the meeting adjourn.
