AUGUST 11, 1980

The Greater Lafourche Port Commission of the State of Louisiana met in regular session in the Conference Room of the Commission Administration Building in Galliano, Louisiana, on Monday, August 11, 1980 at 3:00 p.m. pursuant to the provision of due notice given in writing to each and every member thereof, and duly posted in the manner provided by law.

President Pye Theriot convened the meeting and announced the purpose of the meeting in accordance with the aforesaid written notice.

It was agreed that the Board at present wishes to object to the request of Mud Pits, Inc. until more information can be obtained and a more detailed study can be made.

On motion of Nerby Collins, seconded by Harrison Cheramie, Jr. and unanimously passed, the bid of Ted's Outboard Marine on the boat, motor and trailer was accepted.

Director Falgout reported to the Commission that work on the removal of derelict vessels from Bayou Lafourche has begun. At present six have been removed and placed on a barge and David Barker is presently working on the barge located in Larose. This constitutes 90% of the first section of the bid completed.

Director Falgout further informed the Board that 2 new Harbor Policemen have been hired in addition to the 2 present policemen and the superintendent. We should now be able to have a 24 hour patrol.

ADVERTISING FOR BIDS - Purchase of 1 Vehicle

Sealed bids for the purchase of one (1) vehicle will be received by the Greater Lafourche Port Commission at the office of the Commission located at 5415 East Main in Galliano; or mailed to P. O. Drawer 728, Galliano, La. 70354; or brought to the Conference Room of the Commission on September 3, 1980, no later than 3:15 P.M., at which time all bids will be publicly opened and read aloud.

Bidders are requested to submit their bids on the following units and/or a higher class unit: 1980 Ford Granada, 1980 Chevy Malibu, 1980 Pontiac Lemans, 1980 Buick Centry, 1980 Dodge Diplomat (all units must be 4 door sedan).

Unit to be purchased must have the following equipment: 200 cu. in. 6 cylinder engine or higher, power steering, power brakes, air conditioning, heater, tinted glass, automatic transmission, AM/FM radio, conventional spare tire, steel belted radials, wheel covers, protection group, bodyside moldings, undercoat.

Bids must include date of delivery.

The Commission reserves the right to waive any formality or to reject any or all bids.

Director Falgout informed the Board that he had met with Lonnie Bewley, a bonding counselor out of New Orleans, and discussed with him future developments of the Port and methods of obtaining monies for financing these developments. A follow up meeting has been planned for sometime in October where Mr. Bewley can meet with some of the members of the Board to present his ideas.

Also Director Falgout reported to the Board that he had met with Jessie Cannon and Louis Savoye, consultants and planners who will be looking out for different soruces of funding to assist the port in its future developments.

Continuing his report, Director Falgout reported that he testified before the Senate Fiscal Affairs and Revenue Committee on Capital Outlay. Reauthorization of \$1,000,000 of the 6.18 million granted in 1979 is necessary since it has not yet been spent. Also, a 5 year capital outlay program for the Port has been submitted and it looks as though we could be spending \$16,000,000 in the next 5 years to fund the three slips along Pass Fourchon and Bayou Lafourche, bulkheading of these slips, the "F" slip construction.

Darryl Marlbrough of J. Wayne Plaisance Engineers reported to the Board that the dredging of Bayou Lafourche, Pass Fourchon and Belle Pass is nearing completion. He said the work is about 83% complete and the final section of the dredging project, the sweeping of an existing port commission slip, was expected to be completed by Sunday. He reported that dredging Belle Pass to depth of 30 feet to a point about 4,000 feet beyond the jetties and the sweeping of Pass Fourchon and Bayou Lafourche to a depth of 24 feet throughout the port had already been accomplished.

Commissioner Ted Martin pointed out that the commission should begin filing the necessary applications in order to get the U.S. Army Corps of Engineers to maintain the deepened channels. Director Falgout informed the Board that getting Corps maintenance of the deeper channel would require congressional action and suggested that the commission begin pursuit of approval of the Corps since it would probably involve a lengthy process.

Engineer Marco Picciola reported that Anthony J. Bertucci Construction Co. had completed a total of 48.6 percent of the work on the extension of the jetties at Belle Pass. He said that 41.1 percent of the 180 day contract time had elapsed on the project. He informed the Board that the project could be completed by the end of the month provided weather conditions held up.

WHEREAS, Martin Fuel Distributors, Inc. has requested the specific permission and consent of the Greater Lafourche Port Commission of the State of Louisiana to assign its lease with Greater Lafourche Port Commission of the State of Louisiana, dated October 11, 1976, recorded in the records of Lafourche Parish, Louisiana, in COB 577, folio 135, under Entry No. 433586, and its lease with Greater Lafourche Port Commission of the State of La., dated November 7, 1977, recorded in the records of Lafourche Parish, La., in COB 611, folio 284, under Entry No. 458297, to Jefferson Bank & Trust Company, Metairie, Louisiana, together with the right of reassignment of said leases to secure an indebtedness of \$1,000,000.00, and to have the Greater Lafourche Port Commission of the State of Louisiana join in and sign the act of assignment together with the

right of reassignment for the purpose of acknowledging its consent to the assignment, and

NOW, THEREFORE, BE IT RESOLVED: That Martin Fuel Distributors, Inc. be, and it is hereby specifically authorized and empowered to assign to Jefferson Bank and Trust Company its lease with the Greater Lafourche Port Commission of the State of Louisiana, dated October 11, 1976 recorded in the records of Lafourche Parish, Louisiana, in COB 577, folio 135, under Entry No. 433586, and its lease with Greater Lafourche Port Commission of the State of Louisiana, dated November 7, 1977, recorded in the records of Lafourche Parish, Louisiana, in COB 611, folio 284, under Entry No. 458297, covering the property more particularly described therein to Jefferson Bank & Trust Company, together with the right of reassignment of said lease, agreement and Paris "Pye" Theriot, President, be and he is hereby authorized by and on behalf of the Greater Lafourche Port Commission of the State of Louisiana to sign the act of Assignment of Real Estate Lease and Agreement, a form of which has been annexed to these minutes for the purpose of acknowledgment of the consent of Greater Lafourche Port Commission of the State of Louisiana to the assignment, together with the right of reassignment.

RESOLVED that the President of the Board of Commissioners of the Greater Lafourche Port Commission is hereby authorized to sign a supplemental agreement to the existing formal agreement of April 21, 1980 between the Department of Transportation and Development and the Greater Lafourche Port Commission which reflects a revision in the Grant-in-Aid Award to allow the total allotment of \$1,600,000.00 to be used solely for construction and project improvement.

Commissioner Roland Guidry then requested that the President appoint a committee to work with the landowners of Delta Farm area in order to negotiate the leasing of property in that area for possible development for recreational purposes. President Theriot then appointed Roland Guidry to act as chairman, and Reed Danos and Harrison Cheramie, Jr. as committee members.

There being no further business to come before the Board, it was moved by Roland Guidry, seconded by Reed Danos, and unanimously approved that the meeting adjourn.
