#### OFFICIAL PROCEEDINGS OF THE GREATER LAFOURCHE PORT COMMISSION December 29, 2020

The Board of Commissioners of the Greater Lafourche Port Commission met in special session on Tuesday, December 29, 2020 at 1:30PM at the Administration Office 16829 East Main Street Cut Off, LA 70345.

President Cheramie called the meeting to order and Secretary M. Callais called roll.

ATTENDED: Harris Cheramie, Jr., Johnny Ordonne, Jimmy Lafont, Larry Griffin, John Melancon Jr., Mike Callais, and Kris Callais

ABSENT: Rodney J. Gisclair, Sr. and Curtis Pierce

President Cheramie opened the floor for any public comment, being none, he presented for the board's consideration to approve the expropriation of parcels not yet acquired for Airport Connector Road and Bridge Project SPN H.011915. Bryce Autin presented to the board a resolution that identifies several parcels necessary for public purpose for the Airport Connector Road and Bridge project which are identified on the right of way map. We have been following DOTD's real estate manual for procedures and guidelines to acquire these properties for quite some time. He stated in the resolution there are some construction servitudes and properties listed however most are on its way to acquire amicably. There are 12 parcels needed and we have signed or received verbal commitments on all except 2 which are Ethel Mae Chabert and Paul Rousse Jr. We are requesting authorization to move forward with expropriations on all parcels if need be. M. Callais questioned the 2 outstanding parcels, which Autin replied Parcel 1-2 and 6-3. Autin stated if the parcel references a "C" that is a construction servitude example of 6-3-C-1 which represents a driveway apron that we will need to rebuild for access to the highway. Melancon questioned if Chabert and Rousse do not sign an agreement with the Port when we would start the expropriation of property, Autin stated he would estimate in a week or two if we do not come to terms. Autin stated he continues to work on them and has spoken to Ms. Chabert this morning and it is a succession issue with Mr. Rousse however he has not been able to make contact in the last few weeks. Cheramie questioned the Rousse location, which Autin replied Mr. Rousse is the first house north of Airport Road on LA308. Executive Director Chett Chiasson stated that it is a succession issue and there is a Will in a safe, but he does not have the keys, so we are offering our assistance to help open the safe. Melancon stated but we can still move forward with the expropriation, Chiasson replied yes. Chiasson stated we can file the expropriation and any time now to until we go to court; we can come to an agreement with them. Upon motion by Melancon second by M. Callais, with no public comment, the board approved the expropriation of parcels not yet acquired for the Airport Connector Road and Bridge Project SPN H.011915 by roll call vote resulting in 7 yeas by Cheramie, Ordonne, Lafont, Griffin, Melancon, M. Callais, K. Callais and 2 absent by Gisclair and Pierce.

President Cheramie presented for the board's consideration to approve the offer set forth in letter dated December 21, 2020 regarding purchase of properties owned by Andrew Martin and Ace Martin. Chiasson stated a lot took place since the last meeting with one main item of Mr. Martin coming to an agreement with Theriot Duet & Theriot (TD&T) for the lien on his property. We do have an agreement signed from TD&T that with this purchase the property will be clear of the lien to have a clear title. The letter dated December 21, 2020 from Henry J. Lafont Jr. states that Mr. Martin accepts the offer to purchase his residence, batture, and real estate for \$665,000. Our previous offer was \$625,000. The letter also accepts the offer to purchase Ace Martin's office building and batture for \$250,000.

recommendation to the board is to approve the 2 offers. Upon motion by Lafont and second by Griffin, the board opened the floor for further discussion.

Chiasson stated before the vote he wants to explain what else Mr. Martin is entitled to outside of the purchase price of \$665,000 and \$250,000. He stated that as part of the Uniform Relocation Act that we must follow, there will not be actual relocation cost due to the purchase price however there will be moving cost. Bryce Autin stated the payments that the Port will be obligated to pay are moving cost which there are 3 ways to determine moving cost. The one that our Relocation Consultant has chosen is the size of his house which comes to \$5,500.00. In order to receive this amount, he would have to show he moved from the house. Autin stated the other 2 ways are reimbursement of actual cost to move which is more labor intensive to review receipts and determine justified cost. He stated the same moving cost will be determined for the Ace Martin office building on the bayou side. Our Relocation Consultant went out this morning and will let us know the amount which should be less than the Martin residence. The other benefit under Uniform Relocation Act that we are required to pay Mr. Martin since he is a residential displacement is to pay reasonable and necessary closing cost on a new house. Again, he would have to prove he purchased a new house and our Relocation Consultant would have to review and approve it is reasonable. There could be other amounts, but they are at the Port's discretion nothing else we are required to pay. Also, with respect to the sale we are close to completing the title work which will be a few weeks to get a title policy and sign the sale agreement so your approval would be conditioned on us receiving a title on the property. Melancon questioned the moving cost, which Autin reiterated the 3 choices and our Relocation Consultant chose payment of \$5,500 for the size of his house with proof of moving. K. Callais confirmed he gets paid only after he proves he moved. Autin replied yes. He can't get paid and still leave everything in the house. Same with the office building. He must prove he moved the stuff out. The board then voted by roll call with 7 yeas by Cheramie, Ordonne, Lafont, Griffin, Melancon, M. Callais, K. Callais and 2 absent by Gisclair and Pierce.

Upon motion by Lafont second by Ordonne, the board adjourned the meeting at 1:46PM.

#### RESOLUTION OF EXPROPRIATION AND DECLARATION OF NECESSITY AND USE FOR AIRPORT CONNECTOR ROAD AND BRIDGE PROJECT

WHEREAS, the Greater Lafourche Port Commission, is a duly authorized political subdivision of the State of Louisiana, Parish of Lafourche, created by Louisiana Revised Statute 34:1651; and

WHEREAS, pursuant to the authority granted and permitted by Louisiana Revised Statute 19:141, et. seq.;

**BE IT RESOLVED**, that the Greater Lafourche Port Commission does hereby exercise its rights and privileges authorized by Louisiana Revised Statute 19:141, et. seq., and does hereby declare its intent to expropriate full ownership of the following described immovable properties for the construction, operation and maintenance of the Airport Connector Road and Bridge Project (SPN H.011915):

## Parcel 1-2

**BE IT FURTHER RESOLVED,** that the Greater Lafourche Port Commission further declares that the above described immovable properties are necessary and useful for the public purposes of commerce and navigation for which the Greater Lafourche Port Commission was created, namely for construction of the Airport Connector Road and Bridge Project (State Project No. H.011915);

**BE IT FURTHER RESOLVED**, that this resolution is intended to comply with all provisions of law, and specifically La.R.S. 19:141, et seq.

A VOTE on the above Resolution and Declaration was conducted at a special meeting of the Greater Lafourche Port Commission on the 29<sup>th</sup> day of December 2020, that of the seven (7) members present on the above date, the Commissioners voting as follows: YEAS <u>7</u> (IN FAVOR), NAYS <u>0</u> (AGAINST) and ABSTENTIONS <u>0</u>.
