Port Commission (GLPC) has
partnered with SailPlan to
deploy emissions measurement
technology throughout Port
Fourchon. This work will make

360-degree view of its emissions.

"We're really excited to partner with SailPlan to get a full view of the Port's emissions footprint using their innovative technology," said GLPC Executive Director **Chett Chiasson**. "With SailPlan's precise measurements, data monitoring, and advanced

platform, we've been able to understand the Port's emissions levels and locations in real-time and we're working to do our part to curb those emissions. In all honesty, many of our tenants and users have already demonstrated a desire to work hard in this sector having implemented changes such as shore power initiatives and cleaner burning fueled vessels that reflect a more environmentally-conscious approach to how they operate their companies."

Following the rollout of the technology, SailPlan precisely measured the Port's direct and indirect emissions and air quality data in real-time.

exactly where their emissions are coming from. Our technology empowers ports and terminals to take steps to reduce their emissions."

Fortunately, the Port's air quality is quite good, a fact that can only be learned through actual measurements. In the rare instances when air quality departed from the baseline, SailPlan sent alerts to the Port and the Port was able to use SailPlan's technology to pinpoint the sources causing the changes in air quality. Armed with this information, the Port understands and can take steps to mitigate these emissions by upgrading its vessels to include shore power and focusing its decarbonization strategy on specific areas of concern.

The Port plans to expand its partnership with SailPlan, adding more sensors to monitor the emissions of the full port, exposure of port emissions to nearby residents in the community, and emissions from terminal to terminal. In instances of unhealthy air quality, the port will receive alerts and recommendations for immediate action to improve the air quality, benefitting nearby communities.

On the heels of last year's hurricane, we bounced back quicker than anyone could have ever imagined. We continue to see progress being made at our South Lafourche Leonard Miller, Jr. Airport thanks to a seal coat, obstruction removal, and Airport Bridge & Connector Road project, which is well

At the same time, we continue to press forward with planned projects to enhance our existing Coastal Wetlands Park and Recreation Area in the Port as well as developing plans to build a new bridge and access corridor to Fourchon Island.

When completed, this project (Fourchon Island) will bring about much in the way of opportunities as we seek to bring rig refurbishment, decommissioning, and a project cargo area to the Port for loading and unloading materials such as items to help construct offshore wind installations in the Gulf of Mexico.

Engagement with and interest in Port Fourchon has never been more robust than now as we stake our claim on being a leader for all offshore energy activity in the Gulf of Mexico whether it be offshore wind or otherwise. Yes, you heard me right, we seek to be a hub for ALL offshore energy activity in the Gulf of Mexico because we have the know-how and people to accomplish any and every goal put in front of us today and in to the

My weekly and monthly calendar has had to have fields added to it to accommodate the appointments, conferences, visits, and other activities that have consumed my waking hours. 
COMMISSIONER SPOTLIGHT:

### **TENANT HIGHLIGHT:**



**RLC** is the leading privately owned independent provider of helicopter transportation services for offshore energy platforms and rigs in the deepwater Gulf of Mexico. The company operates a fleet of 40 plus aircraft.

The Galliano base is RLC's largest (of six) support facilities across the GoM and has been rebuilt/ expanded after hurricane Ida caused significant damage to its operations building. The 'new' Galliano facility has 24 helipads, an 8,000 sq ft passenger terminal, a mobile home park, and parking for approximately 700 vehicles.

Increased activity in the energy sector, driven by higher prices for

hydrocarbons, has resulted in high activity rates from our GAO facility. In September, RLC processed nearly 4,000 passengers and over 1,500 flights to/from the new and improved Galliano Heliport facility.

The Greater Lafourche Port Commission and Lafourche Parish leaders hosted the head of the American Petroleum Institute on Oct. 19th, giving him a tour of Port Fourchon, touting the port's strategic advantages and presenting united support expanding drilling opportunities in the Gulf of Mexico.

# AIRPORT PROJECTS CONTINUE — TO MOVE RIGHT ALONG — WITH MORE IN THE OFFING

Being an airport that ranks among the very best in terms of its economic impact in the entire state doesn't happen by accident.

The South Lafourche Leonard Miller, Jr. Airport continues to pursue an ambitious agenda of projects and upgrades to not only maintain itself as a state leader among general aviation facilities, but build on that success moving forward.

In recent months, the airport has seen its fair share of projects ranging from obstruction removal to a putting a brand-new seal coat on its runway and parallel taxiways.

The GLPC is also teaming up with Lafourche Parish Government's Economic Development Director Kristi Lumpkin to work on getting certified sites established at

the airport through a program administered by Louisiana Economic Development (LED).

An agreement is close to being reached that would certify several hundred acres for potential use by companies, as the airport seeks to have an industrial park area as well.

When combined with the pending construction of a new terminal building in the coming months and continued work on the Airport Bridge and Connector Road project that will join to Highway 3235 allowing superior access to the airport and Port Fourchon, it is clear to see the future of aviation in Lafourche Parish is on solid footing.

"What we are seeing is a convergence of a number of projects at the same time," **GLPC** 

Executive Director Chett Chiasson said. "We really are trying to time things up to where you see all these efforts and milestones meet up simultaneously to show we are meeting the demands of not only our tenants, but potential users of our airport located firmly inside our

flood protection system."

After accounting for recently completed and future projects planned at the airport, Chiasson feels strongly that this economic impact will only rise in the coming years.

Pitre, a longtime businessman and community steward known for starting the Team Tom moniker at Tom's Texaco in Golden Meadow, is also a great fit on the board thanks to his lifelong devotion to the 10th Ward and its residents.

Both men said they are humbled and honored to serve as Board members.

GLPC Board President Chuckie Cheramie said he was happy to again work beside Commissioner Savoie, while also adding he was very excited to have Commissioner Pitre join the ranks, as the Board continues its important work for Port Fourchon, the South Lafourche Airport, and the South Lafourche community.

Port Commissioners are elected to six-year terms and serve the community of the Tenth Ward of Lafourche Parish at large. The Tenth Ward is comprised of the area of Lafourche Parish south of the Gulf Intracoastal Waterway to the Gulf of Mexico.

This agreement entitled us to put signs up at each of these locations


with our logo on them.

# DID YOU KNOW?

Port Fourchon has what is believed to be the only Coastal Wetlands Park on the globe. The nearly 100-acre site constructed from dredged materials from Slip D features a nearly one-mile long tidal creek, fishing dock and kayak launch, as well as a parking area. A bridge helps provide an ingress and egress of tidal flow from the adjacent Flotation Canal that runs parallel to the park.
